Scaling-up - Evidence of (cost) effectiveness; Advocacy



Highlights from the Evidence

Stable housing

- Canada: Housing First service users spent 73% of their time stably housed over two years, compared to 32% of those receiving other homelessness services (At Home/Chez Soi)
- EU evaluations: 80+% housing retention (Housing First Europe research project)



Un Chez Soi-d'abord First observations

(13 months average follow up -172 participants)

- More than 1 in 4 have re-established contact with their family
- 12% have accessed employment or professional training; 20% volunteer activities
- 40% live autonomously (home maintenance, relations with neighbours...) and manage to meet their basic needs
- 15% have regular contact with mental health services since entering the program (even if not mandatory for accessing housing)



What IS Housing First?

Housing First uses housing as a **starting point** rather than an **end goal**. Providing housing is what a Housing First service does before it does anything else...

A Housing First service is able to focus immediately on enabling someone to successfully live in their own home as part of a community.

Eight core principles:



Housing is a human right



Choice and control for service users



Separation of housing and treatment



Recovery orientation



Harm reduction



Active engagement without coercion



Person-centered planning



Flexible support for as long as is required





1. Housing is a human right:

Legal security of tenure, affordability, habitability, location, etc.



2. Choice control for service users:

Self-determination = starting point, shared decision making, essential to recovery model







3. Separation of Housing and Treatment

Housing is not conditional on behavioural change or accepting treatment

4. Recovery orientation:

Focus on the overall wellbeing of an individual including mental and physical health, social support and social integration







5. Harm reduction

Harm reduction seeks to persuade and support people to modify drug and alcohol use that causes them harm...and offers support, help and treatment but does not require abstinence.

6. Active engagement without coercion

Positive engagement with HF users to engage with the help that they need.







Organise support and treatment around an individual and their needs; emphasis on choice and control for service users.



8. Flexible supportas long asrequired

Support intensity can rise and fall with individual need, from a few months to beyond.

Needs change over time.



Planning issues – making the shift

- Embed Housing First in a broader planning framework
- Bring in the experts
- Coaltion building and Partnerships



Planning issues: Partnerships are Key

"So get everybody and anybody together. If you aren't sure whether they should be involved, invite them anyway. One of the greatest advantages of collaboration, especially in the early stages, but is important throughout, is that those at the table and part of the development now have a vested interest, when they feel like they are part of something bigger than they are and have influence they become supporters instead of antagonists.

Y-SÄÄTIÖ (Y-Foundation) & FEANTSA joint initiative – 2016

- Focus on activities to share learning and scale up Housing First
- Hub Partners are committed to the core principles of Housing First as defined in the Housing First Europe Guide



Training

- Establish pool of trainers and regular 'train-the-trainer' seminars
- Support local Housing First networks and respond to specific training needs, e.g. Training for social workers, housing workers, etc.
- Develop university course



Practice

- Advocacy: Develop tools for Partners and others to support scaling up of Housing First at local, regional & national level
- Support communities of practice national networks
- Roadmap for scaling up Housing First in a medium-sized city
- Housing First for Youth development of model and trial





- Federation of national organisations working with homeless people
- 110 members in 25 EU Member States
- Committed to ending homelessness in Europe
- Facilitates knowledge sharing, advocacy, research



Research

- Monitor research & evaluations of Housing First projects
- Create an evaluation template for Housing First projects
- Make research available to make the case for Housing First
